In case of cancellation from you, the amount of the sums held on the refund is calculated according to the scale below. An inexcusable delay - of more than five days - of this declaration could pull the non-refund More than 60 days before the departure, your deposit is paid off to you. 60 days and less before your departure is retained the amount following by the trip:

·between 60 and 21 days: 30 %.

between 20 and 2 days: 65 %.

•non-presentation(non-display): 100 %. If you cancel 8 days before all of the horseback riding is held.

Cancellation from us
